

He has also assisted in the defense of preference, fraudulent transfer, and automatic stay violation claims, and the prosecution of complaints for exception to discharge, motions for relief from stay, motions for adequate protection, and plan objections.

As a commercial litigator, Mr. Feuille has successfully first-chaired two jury trials and one bench-trial. In addition, Mr. Feuille has obtained numerous summary judgement victories on behalf of one of his more active collections clients.

As a member of ScottHulse’s Labor and Employment practice group, Mr. Feuille has advised employers regarding employment policies and handbooks, non-compete agreements, and avoiding potential employment discrimination claims.
